The proposed changes of use and internal alterations at upper ground and first floor levels of the northwest wing of Building No. 4D will result in: a change from former restaurant use of Unit No. 5 at first floor level to use as an Arts Centre (132 sq m); the insertion of an lift/stair access lobby from upper ground to first floor level (36 sq m over two levels); and the amalgamation of Unit Nos. 3 and 4 at upper ground floor level to one new unit of 123 sq m, whcih is to be retained for restaurant use.
